Red Cliffs Rifle & Pistol Association requires the passing of the NRA Certification Class and RCRPA membership to become a Range Safety Officer. We also require our RSOs to pass a background investigation. *The background investigation may be waived if you possess a valid Utah Concealed Firearm Permit (CFP), and we require all RSO applicants to have the CFP, or to have the CFP pending before taking our NRA RSO Class.*

The **COST of the NRA RSO Certification Class is \$100.00.** You also agree to renew your NRA RSO Certification as necessary and furnish renewal proof to the RCRPA. To maintain your volunteer RSO status with the RCRPA, you agree to volunteer a **minimum** of 60 hours per year (4-5hr shifts = 12-15/yr) and to follow our standard operating procedures. Understand that by signing below and taking our Range Safety Officer course, you have entered into a legal contract with us!
